#### 2025 Chef / Cook Application

You have an opportunity to earn income if you bring more than the minimum amount of food. .

We expect that you will bring a minimum of **600 bacon food samples or appetizers** to the event. This is very important because our total ticket sales to the event is based on all cooks bringing at least this amount of food. Event attendees will provide you with a food ticket and you will provide them with your food item. At the end of the day KBA will collect your food ticket container and we will count the food tickets.

**Earn More**: If you bring and distribute more than the minimum required 600 food samples you can earn additional income

If we have a ticket count over 600 you will get \$1.00 for each food sample after 600 up to 800 samples. If you bring and distribute 800 or more food samples you will get \$2.00 for each food sample past a count of 800. See the examples:

**Example 1.** Cooks that distributes 800 food samples get an additional \$200. (Which is \$1.00 per sample past the 600 sample count).

**Example 2**. Cooks that distributes 900 food samples gets \$400 That's \$200 for the food ticket count between 600-800 which is at the \$1.00 per sample rate and another \$200 for distributing the additional 100 food samples past 800 at the rate of \$2.00 per sample.

**Food Judging**: 1st, 2nd, and 3rd food judging will be based on originality/ unique use of bacon, flavor, presentation, and aroma. Also, how you represent your business with a creative and clean booth. Remember that you represent your business. Show the public what you've got! In addition we will have a peoples choice award.

#### **SET UP & TEAR DOWN TIMES:**

**SET-UP TIME**: 7 AM to 8:30 AM. Please be on time

Gate opens to the public at 11:00 am.

Be ready to serve food by 10:45 AM to Food

Judges and more.

TEAR DOWN TIME: 4 PM. (NO SOONER THAN 4PM)

Be sure you remove all garbage and take your waste grease and oil with you when you leave. KBA will provide dumpsters for garbage.

**LOCATION:** KBA will contact you to direct you to a designated location on main street in Kelseyville.

#### WHAT TO BRING

- 1. <u>600 bacon appetizers minimum</u>. If you want to make more \$\$\$ bring more than 600 appetizers because we expect more than 2000 attendees. **No food vendors will attend this year.**
- 2. One 10 x 10 Shade Tent (preferably white canopy tent). If your bringing a food truck or trailer we need to know the length of the unit ASAP.
- 3. Hand Wash station
- 4. Serving Table
- 5. Paper plates utensils or what ever you will need to serve your appetizer
- 6. LAKE COUNTY FOOD PERMIT. KBA will provide you a copy to complete.
- 7. Electrical power. If you require power please let us know at lest two weeks before the event and not on the day of the event. **NO GENERATORS!**
- 8. Please provide something to collect your oil and grease.
- 9. Fire Extinguisher
